Angel Action is the volunteer program of Community Action for Wyoming County. The founder is a one-time recipient of Community Action services who served on the Board of Directors and recognized a need in our community that was not being met. That need was help for working families whose incomes fall just above the guidelines for assistance and have no place to turn for help.

These families often find themselves without the means to purchase food, medicine, clothing and other basic necessities that we take for granted. We assume that these services are provided to all families in need through the normal service agencies but that is not always the case.

Angel Action is based on the belief in the "Circle of Giving". People that we help are asked and encouraged to help others in return. Volunteers throughout Wyoming County have recognized their responsibility to their neighbors less fortunate and have come together in an organized effort that is producing amazing results.

These volunteers and the people they serve depend on the successful and generous members of our community, such as you, to help them continue their work.

100% of the money raised by volunteers is returned to families in need.
